Our Commitment to Privacy

At Seminars International we are committed to maintaining the confidentiality, integrity, and security of your personal information. We are committed to protecting your privacy and providing you with a secure online experience. Seminars International does not sell, transfer or disclose any personal information about its users to third party sources. This privacy policy discloses how we collect, protect and use personal information gathered about you. We use reasonable precautions to keep any personal information collected secure. We follow industry-standard precautions and procedures in the transmission and storage of electronic data allowing online users protection from interception of private information by any third party. Security

The Seminars International website and online forms have security measures in place to protect the loss, misuse and alteration of the information under our control. Only authorized employees are permitted to have access to this information. The network and database are password protected. Relevant personal information may be shared with our overseas partners and with airlines for the purpose of managing your program. Our overseas partners are in compliance with international or other personal data regulations, such as the European Union General Data Protection Regulations.

Information we collect and how we use it

In order to perform our business activities and provide services to you, Seminars International may collect and hold personal information. We may also collect personal information from you in order to get your feedback about our website, send you our newsletter and/or other news, or emails regarding updates.

Seminars International may use your personal information for several purposes such as:

1. Administering services we are providing such as travel and logistical arrangements for your program.
2. Communicating with you regarding your program's arrangements and contacting you in the event of an emergency.
3. Providing relevant information, which may include sensitive personal information, to insurers, their agents or medical staff in circumstances where we/they need to act on your behalf or in the interest of other participants or in an emergency.
4. Providing relevant information to our overseas partners. (Our European partners comply with the European Union General Data Protection Regulation.
5. Making our website easier for you to use by not requiring you to enter your personal information more than once.
6. Helping you quickly find services or information.
7. Contacting you when you have received an error while using our website or online forms so we can help you solve any problems.



We use reasonable precautions to keep any personal information collected secure. Any sensitive personal information (such as health or passport information) we collect is stored in our secure database.

Payment for Services

Financial information (credit card numbers, credit card expiration dates, billing address, etc.) is required for online payments. Customers must provide this financial information so that we can collect payment for certain services. Customers have the option of paying by credit card over the phone if they choose not to submit payment through our site. We delete customer financial information as soon as the credit card information has been processed. We use secure connections (SSL) when accepting payments online, which means all information is encrypted before it is sent over the Internet between your computer and our computers or those of our service providers. When we receive your personal and financial information, it is stored and protected by a firewall. The firewall is designated to protect anyone from viewing, stealing or accessing the information.

Disclosing Information

We will disclose your information, without notice, only as follows:

1. To obey orders of the law or comply with legal process served.
2. To protect and defend rights or property.
3. To act in urgent circumstances to protect our website, our database, our employees or the public.
